APPENDIX B

Conditions of Use

In cases where PARO owns the copyright in the material or has been given authority to administer copyright, copyright clearance is granted by PARO for one-time only, non-exclusive use over a five year period. If PARO is not the copyright holder, information about the rights holder will be provided to users if it is known. The use of a credit line when publishing materials still under copyright is no substitute for obtaining prior consent from the copyright holder. Materials in the public domain are free from copyright restrictions.

Copies and reproductions are provided to users with the understanding that they will not be deposited in any other repository without written permission from PARO.

Formal credit ("Public Archives and Records Office of Prince Edward Island") is required for all uses of material. The credit line for each image should read as follows: "Public Archives and Records Office, [accession number, series, file, and/or item number]". Citations may be shortened to "PARO PEI [accession number, series, file, and/or item number]" if needed. For diffusion on television or video, a single credit is acceptable.

Items provided for print or electronic publication may not be altered in any way without written permission from PARO. Any alterations or manipulations must be indicated in an accompanying caption in order to preserve the historical and artistic integrity of the original.

Images provided for use on a website must appear online at a resolution no higher than 72 dpi.
